



## Notice of SandRidge Owner Relations Online System and Direct Deposit Enrollment

We are pleased to announce that SandRidge Energy Inc. has partnered with PDS Energy Information to provide an Owner Relations Online System where you may obtain your revenue check detail and your JIB invoices, free of charge, via a secure internet website 24 hours a day, 7 days a week. Our Owner Relations Online System will enable you to view and print your check detail in the same format as the paper check detail you currently receive. This service is optional and you will continue to receive your paper checks if you choose not to sign up. You will also continue to receive your emailed JIB invoices.

In addition to the new Owner Relations Online System, SandRidge is now offering the option of Direct Deposit of your checks. **To enroll in Direct Deposit simply complete the attached form and return a signed copy to SandRidge Energy.**

As a revenue interest owner, you will have access to your check detail and invoices by logging onto the SandRidge Energy website. You may view and print the statements or elect to have the information automatically emailed to you each month as new check details become available. All check information from August 2012 and forward will be available.
